## **Research Methods**

Author (s) did explained 25 people as informants, however the Authors (s) not mentioning any key informants, communication situations, and context in which communication occurred.

## **Technical Quality**

In the manuscript, the Authors (s) mention a lot regarding "as illustrated in Fig. 1, as illustrated in Fig. 2 and as illustrated in Fig. 3", however there is not any Fig. displayed.

## Citations

The paper show inconsistent in citation related with typography, year citation and co author miswriting. For example, it cites Velkora 2016 while there isn't any velkora in reference. In reference it shows Velkova. Furthermore there is also inconsistent regarding the year that author (s) cite. The author cites Trahan 2014 while in reference 2013. The paper cites Baxter 2008, while in reference it cites Baxter and susan 2008. The author (s) need to be clarified this err, whether it is Velkova or Velkova, 2013 or 2014, and Baxter or Baxter and Susan. By doing this revisions, the author (s) appreciate others authors and their findings.






