Thank you for submitting your paper to Brazilian Journalism Research (BJR). We regret to inform you that, after a preliminary review, we have decided to refuse the article.

This manuscript seems to be closer to an essay. The subject is really relevant and it would be interesting to publish a more advanced paper on millennial female journalists in Surabaya, Indonesia. BJR strongly recommend transforming the manuscript into a proper research article and resubmit it again.

The manuscript lacks a methodological section. In the introduction, the author mentions this is a qualitative research, based on interviews and observation of 19 Indonesian millennial female journalists. However there is no information on how these women were chosen, when the research was conducted and how their narratives were explored. More importante I could not see an empirical/analytical section where the results were discussed. Maybe interviews supported a theoretical debate about this subject but in this case we cannot consider the paper as a research article.

We understand that this editorial decision may be disappointing, but BJR strongly recommend resubmit the article.
