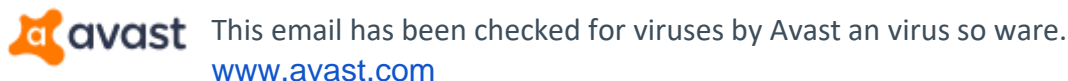
This paper seems to be good and suitable for publication. However, this paper should be revised as per the comments given below:
